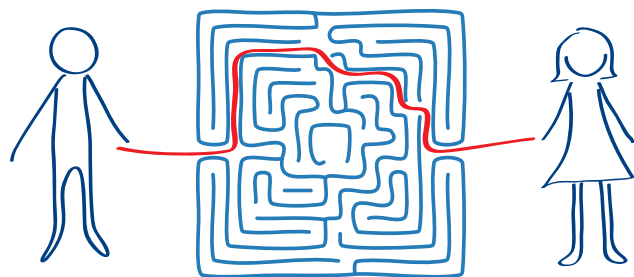
➤ **Rebuild relations between man and woman:** reconciling both sexes.

Our Proposition

Between the woman seen as a sex object or as a breeder, a third way : a responsible woman communicating with man.

Men and women, for their own happiness and the survival of humanity, are made for a reciprocal relationship based on respect and valuing of their differences.

Equal in dignity, they need to be aware of their own specificity to be able to assume their mutual responsibilities in family life, in their job and in their community.

Complementary to each other, men and women thrive best when acting in concert, related and united. Thus they can reach their own fulfillment and play their part in the harmony of the world.

A woman reveals his masculinity to a man. A man reveals her femininity to a woman.

The family built on the union of a man and a woman is the basic social unit. A family is an unbroken chain of generations that allows for transmission. It is the first and foremost forum for education and socialization. It is the breeding ground where a child can learn how to share, to care and to assume his alterity.

Every human being has the right to respect and to life, from conception until natural death, regardless of sex, race, religion, health status, circumstances of his or her conception or his or her actions.

A bad solution to real-life problems

In the 1960s, feminism evolved. Women refused to be treated as sexual objects or breeders. Women came into competition with men to gain their autonomy. The invention of the pill then allowed dissociating sexuality from reproduction.

At the UN Conference on Women in Beijing in 1995, **gender** broke in and gained control. A new ideological war is being waged putting man and woman's humanity at risk. Human Rights are twisted in order to impose a new civilization serving the powerful.

Gender is a short-sighted concept: it reduces our identity to our sexual behavior. It denies the reality of the physical complementarity of men and women. Sexual orientation foregoes physiology. Both sexes disappear for the sake of multiple gender identities. **Gender** aims at disconnecting reproduction from the union of a man and a woman, therefore advocating artificial reproduction.

The UN imposes **gender** mainstreaming for the sake of development and peace. Nevertheless **gender** has failed to fulfill its promises. It breeds division, separates men and women and disrupts women's identity. Such a disruption impacts men, couples, families and society at large.



Family is based on alterity, fertility and faithfulness whereas gender is narcissistic, sterile and changing. Gender isolates whereas family bonds. Gender deconstructs whereas family constructs.

Promoting

- A free choice for women : reconciling work and family life.
- The value of the invisible and non-market work carried out by women.
- The role played by women in the transmission of an oral culture and an intangible heritage.
- The contribution of women to development, peace and the common good.
- Women's role in society in all aspects without discrimination, violence or exploitation.
- Women's identity in its full dimension in complementarity and reciprocity with men.

The woman reconciled with herself will be reconciling for the sake of the family and the society at large.

- Manipulation of human rights by finance lobbies or pressure groups.
- Gender mainstreaming into treaties and conventions.
- A deliberate dismantling of nature for the benefit of a new artificial culture.
